2. The DOH-REGIONAL OFFICE X now invites bids for the supply and delivery of the above-stated packages.

Bidders should have completed, within the last three(3) years period from the date of submission and receipt of bids and have a single contract that is similar to this Project, equivalent to at least twenty five percent(25%) of the ABC for Packages 35,36,37,38,39, 40, & 41 and fifty (50) percent of the ABC for Packages 31, 33 & 34. The description of an eligible bidder is contained in the Bidding documents, particularly in Section II. Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from the BAC Secretariat, DOH-ROX at the address given below during working days, 8:00 am to 5pm.

5. A complete set of Bidding Documents maybe purchased by interested parties from the BAC Secretariat at the address below and upon payment of a non-refundable fee (pls. Refer to the table above)

6. The DOH-ROX will hold a **Pre-bid Conference on November 9, 2015, 10:00 o'clock in the morning, at the ROX Conference Room, DOH-ROX, Carmen, Cagayan de Oro City**, and any interested parties may attend in this activity.



Time reference is the Office Biometric Clock. All bids must be accompanied by a bid security in any of the acceptable forms in the amount stated in ITB clause 18.

Bid opening shall immediately follow on the same day at the ROX Conference Room, DOH-ROX, Carmen, Cagayan de Oro City. Bids will be opened in the presence of the bidders or their representatives who choose to attend. **Late bids shall not be accepted.**
